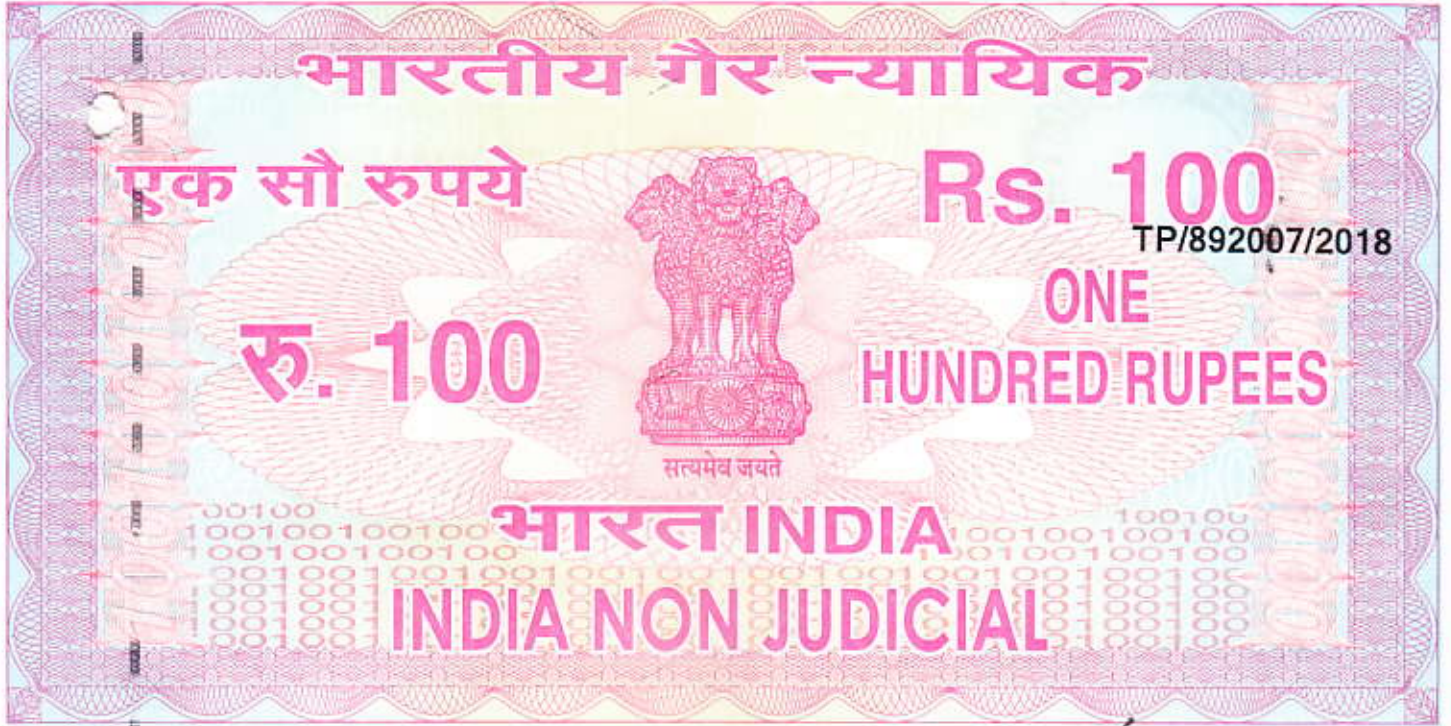

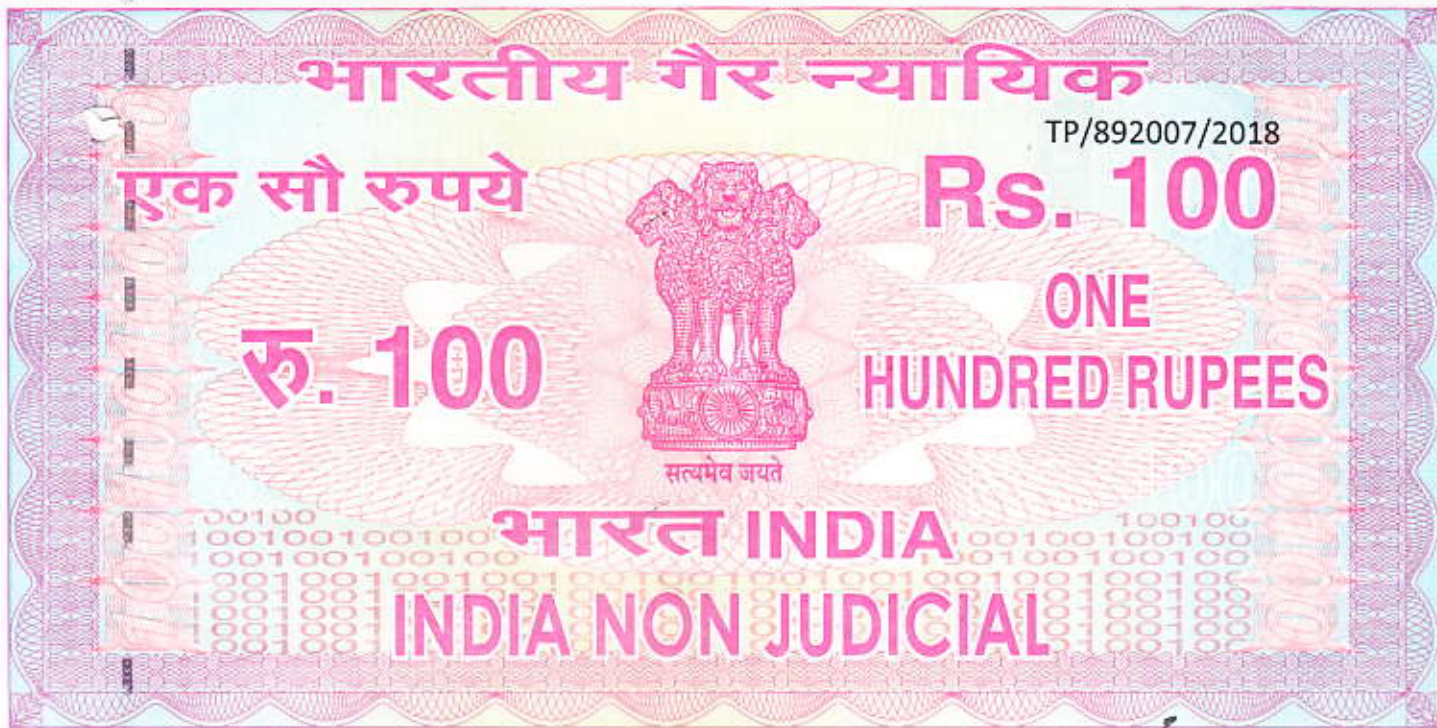
This Deed of Trust executed at Vellore on this 26th day of February 2018 By :-

We the Trustees herein, have decided and agreed amongst ourselves that we shall constitute the first Board of Trustees, hereinafter referred to as trustees, the number of Trustees can be increased to maximum member of Nine.

R.Manimegalai, is the founder and author of the Trust and has set apart and contributed initially a sum of Rs.1000/- in trust to be held as CORPUS for carrying out the purpose and objects set forth in this deed.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:-

- 1) At present there is no immovable assets belonging to the trust, the trust fund shall be the initial contribution of Rs.1000/- set apart as here in before mentioned and other contribution and donations that the trustees may hereafter receive either being kept as CORPUS or being dealt with the team for being expended for the various objects and proposes of the Trust herein after mentioned.
- 2) The trustees do hereby acknowledge that the trust stands possessed of the sum of Rs.1000/- given by the author.
- 3) The objects of the trust shall be all or any of the following: -
 - a) "P.M.SOMASUNDARAM MUDALIAR TRUST" is a non-political, non-religious, non-profit non-sectarian, charitable and voluntary, Education centre, and Social Work. To provide social upliftment, women development, health Education to poor youth and to provide health programme, in rural and urban area.
 - b) To impart useful and educative information in all matters affecting social economical cultural and scientific life to the public in general and particularly to the ignorant people of undeveloped remote villages urban, town and to youngsters to make them better citizens.

- c) To start and run, maintain, manage, administrate of Schools, Metric Schools, High Schools, and Higher Sec. School, Lab Tech Institutions, Hospitals, Clinical Labs with sophisticated equipments, Clinic Health Laboratories, Industrial Training Institutes, Industrial Training centers, Polytechnic, Nurse Training Institutes/Colleges, Hospitals, Arts & Science Colleges, Engineering Colleges, Architect Colleges, Medical Colleges, any other Colleges or Institutions, Technical Courses, Diploma courses, NCVT and SCVT approved Training Centers/Institutes Degree/Diploma courses, Teacher Training courses, Bed Colleges, University, Deemed University etc., with or without aids of the Government of State or Central, or Foreign aids anywhere in India.
- d) To start the training for Women and Youth for skill Development.
- e) Paramedical Institute or Social Institutes.
- f) To open training centers for village level animators, motivators and health workers, and to serve for the sound of Deliverance, community development, to give speeches for the benefit of the general public.
- g) To promote health programmes, Issue free medicines and teach and propagate preventive health care, health education, family planning, immunization programme etc.,
- h) To start and maintain, hospitals, medical, Non-medical colleges, Medical diploma courses, Nurse training colleges and other medical technical, training courses etc.,
- i) To start women sangams and conduct women's awareness meetings. Provide Women Education and Child Education. To provide Health Awareness and Health Education. To provide income generation trainings and programmes, to provide general awareness.

- m) To start vocational training, centers from women and men and to start nursery schools for children's.
- n) To start maintain and manage formal or non-formal schools, colleges, evenings and day colleges Training schools, any Education Institutions, etc., any were in India.
- o) In collaboration with government and other agencies.
- p) To open orphanages and hostels & Old age homes.
- q) To start Adult Education and non-formal education and run high schools for and benefit of illiterate adults.
- r) To open physically handicapped, deaf, and dump, schools and conducted programmes.

- 1) To raise funds by subscriptions, donations, and contributions, from the public and by approaching the authorities, of the state and central government for the aid and to seek the financial help by all means and sources and also to seek foreign aid, for the betterment and maintenance of the educational Institutions orphanages and hostels, hospitals and other programme run by the trust. No funds/profits/income shall be distributed to members/trustees in any from such as dividend or interest etc.
- 2) The Trust is IRREVOCABLE.
- 3) The trust shall invest the funds in accordance with the provisions of sec 13(1) (d) read with sec 11 (5) of the Income tax Act 1961.
- 4) The accounts shall be audited by the Chartered Accountant. The Income/funds of the Trust will be solely utilized towards the objects of the trust and no portion of it will be utilized for payment to trustees/members defined in section 13 (1) (o) of the Income Tax Act.
- 5) No Activity shall be carried outside India. The trust shall not carry on any activity with the intention of earning profit. The activity should be purely Charitable Nature.
- 6) To accept the loans from central government state Government N.G.O.S. Private sector, Banks for achievements of common objects and to the documents shall be signed by chairman R.Manimegalai, Any accounts may be opened in any nationalized or scheduled bank; such accounts shall be operated by Chairman R.Manimegalai. The Trust shall apply for Loan for any bank, such any loan from Banks or other authorities, such loan account shall be signed by Chairman R.Manimegalai.
- 7) To issue term loans to the poor people for Economic Development programmes at a nominal service charges.

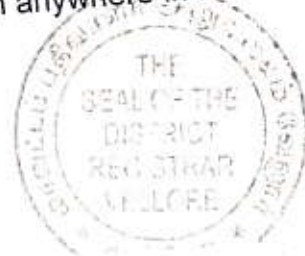

MANAGEMENT

- 1) The number of Trustees in the Board of Trustees shall not be less than two; additional trustees may be appointed for specific periods by the Founder & Author of the Trust.
- 2) R.Manimegalai, is the author and founder of the trust, She is the chairman of the Board of Trustees and hold office till her lifetime (or) till her resignation.
- 3) R.Santhoshkumar, shall be the financial Trustee. He shall hold the Office for his Lifetime, or till he resigns.
- 4) The Board of Trustees shall meet at least once in Six months to transact business.
- 5) Proper books and accounts regarding the moneys, received investments made, expenditure incurred etc., as well as of the properties, both movable and immovable assets, securities, documents and liabilities etc., of the trust shall be maintained properly.
- 6) The Registered Office of the Trust located at No.88 veppamara street velapadi vellore and another office at No.222/1, Amman Koil Street, Sevoor village, Arni Taluk, Tiruvnnamalai District, Pin 632316, The office premises may be changed to suit the conveniences of the trust and as per the majority decision of the Trustees, the Branch or Branches may be opened in anywhere in India.

FUNDS

- 1) The trustees will open one or more accounts with schedule Banks, and Nationalized Bank; all transactions shall be operated by the Chairman its later amendments.
- 2) A Chartered Accountant shall be appointed by the board of Trustees, for the audit of reports shall be considered by the Board of Trustees.
- 3) The Trustees shall frame such Rules and Regulations and Bye-laws as they deem fit and necessary for the purpose of proper efficient and effective functioning and administration of the trust and the institution, established and administered by the trust, and for the proper utilization of the funds in accordance with the various objects and purposes set after any of the Rules and Regulations and Bye-laws, so that the affairs, of the Trust could be effectively and properly administered.
- 4) In case of dissolution of the trust for not being able to function all the movable and immovable properties belonging to the trust shall be handed over to any other trust or institutions having the same objects (or) objects similar to those of this trust, and enjoying exemption u/s 12AA and 80G of the Income Tax Act.
- 5) Not more than 5% of the income of the trust/institution would be applied for any religious purposes or given to religious institutions.
